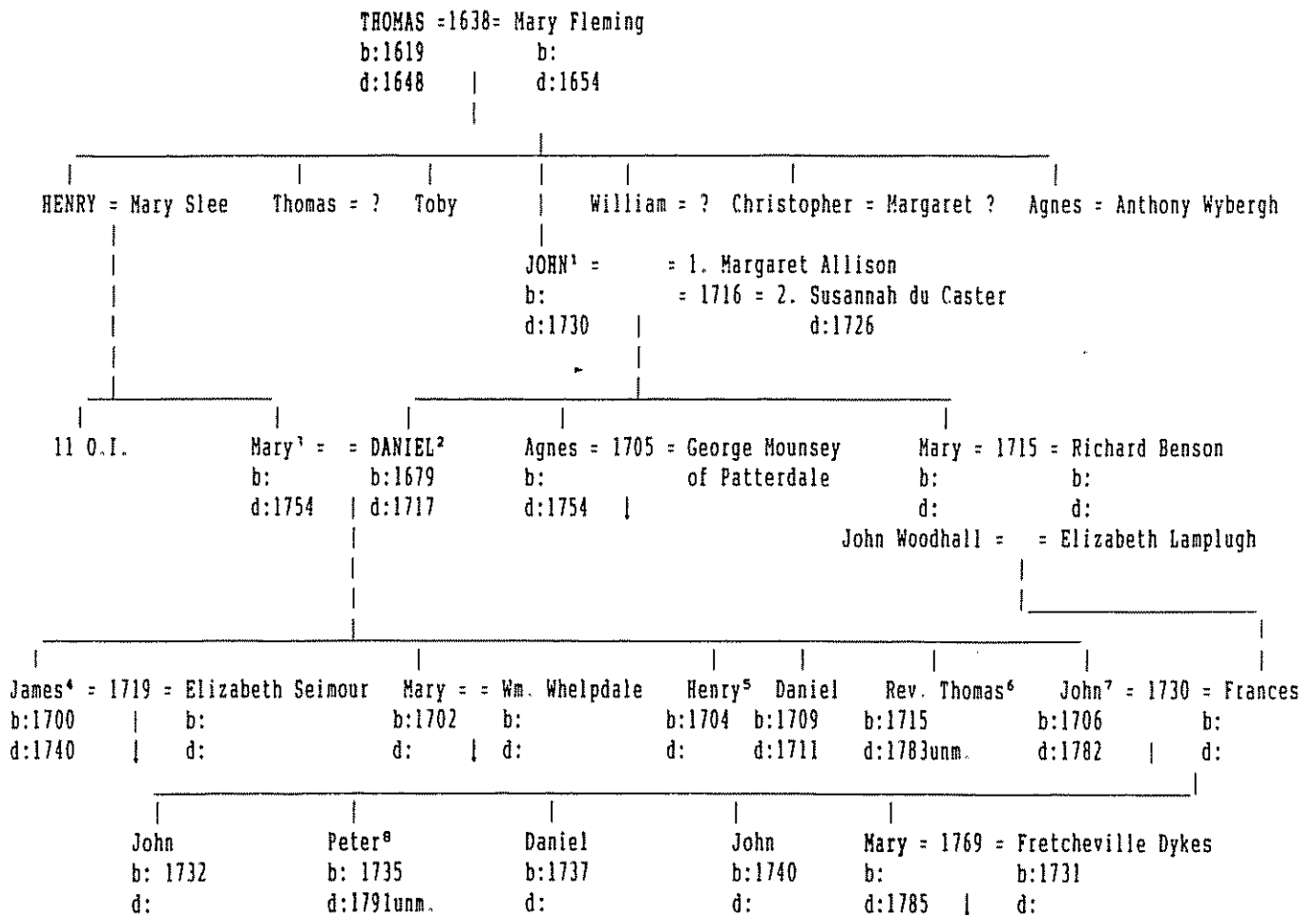

BROUGHAM OF STAVELEY, NEWCASTLE, & COCKERMOUTH



1. John Brougham the Elder, sometime High Constable of Kendal, was of Lower Fairbank, Staveley, Westmorland.
2. Daniel Brougham was appointed Collector of Customs, Carlisle, in 1709, and Port Surveyor of Newcastle in 1713 at a salary of £60 pa. He was a godson of Daniel Fleming.
3. Mary Brougham inherited the Fairbank estate from her brother, Commissioner John Brougham, who had purchased it from his uncle, the High Constable.
4. James was the father of an illegitimate son by his cousin, Grace Brougham (whose grand-daughter, Grace Idle, married Dr. James Brougham). He married Elizabeth Seimour, by whom he had two sons, (James, bp. Wantage 20.09.1720; and Daniel Semore bp. Sunderland 18.02.1722) at the Fleet Prison 18.08.1719.
5. Carlisle Grammar School 1712; Queen's Coll. Oxford 1720; BA 1727, MA1728. No further information.
6. Rev. Thomas Brougham was vicar of Kingsey, Bucks. He received the news of the death in London of his nephew, Daniel Seimour Brougham, 25.12.1778
7. John Brougham was an attorney of Cockermonth. He married Frances Woodhall, whose mother was the former Elizabeth Lamplugh, at Lorton. The claim by the first Lord Brougham to be heir-general of the Lamplughs of Lamplugh is unfounded: that claim could only have been made by the heirs of Mary Dykes.
8. Peter Brougham took the name and arms of Lamplugh, and succeeded to the estates of his father, his uncle (Rev. Thomas Brougham), and his great-uncle (Rev. Bernard Brougham); and bought Scales from his cousin, Henry Brougham the Younger. He died unmarried, and his niece Mary Dykes, who had married her cousin Joseph Dykes Ballantyne, carried the estates of Dovenby (inherited from the Lamplughs) and Scales to the family of Dykes.

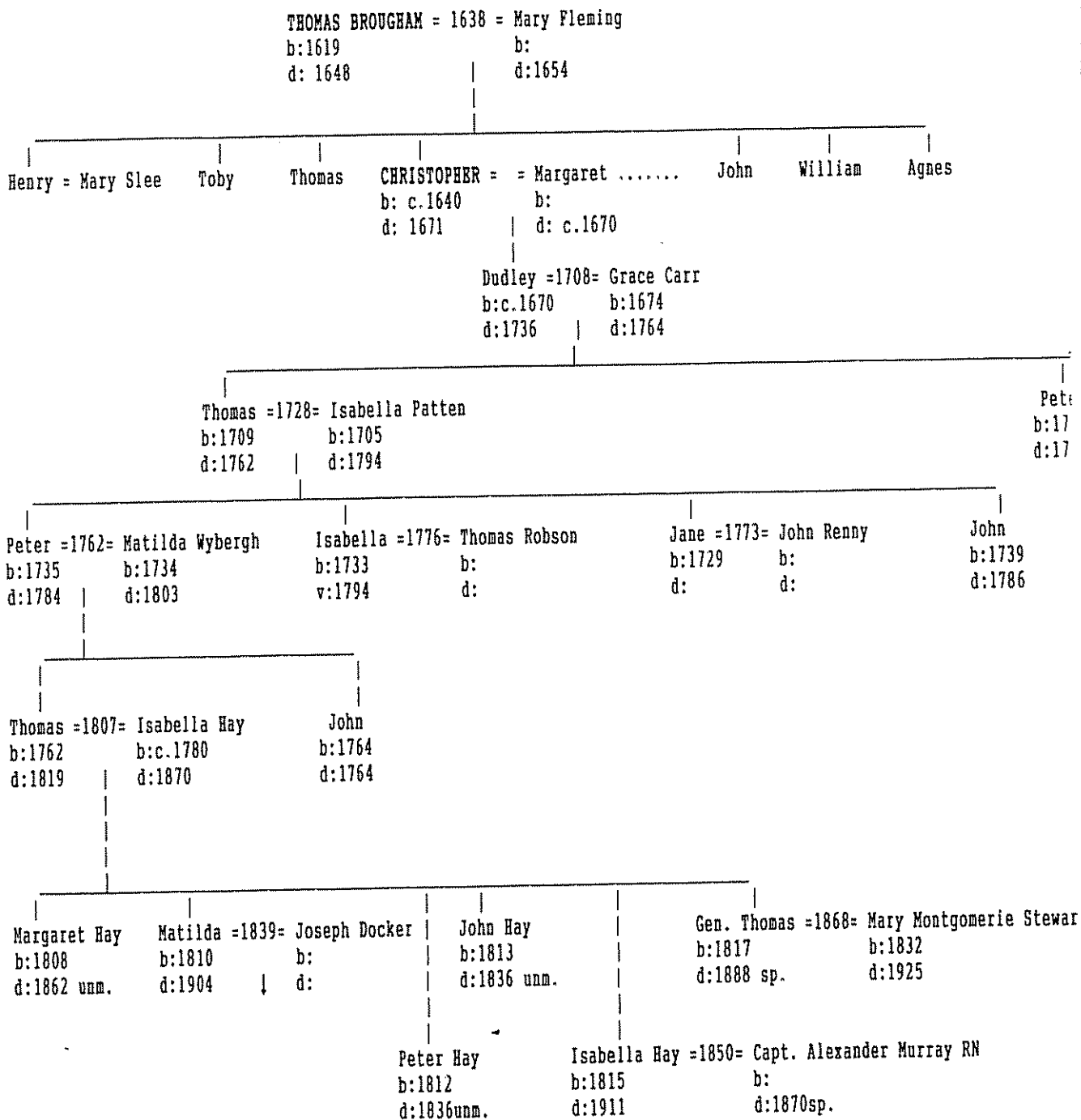

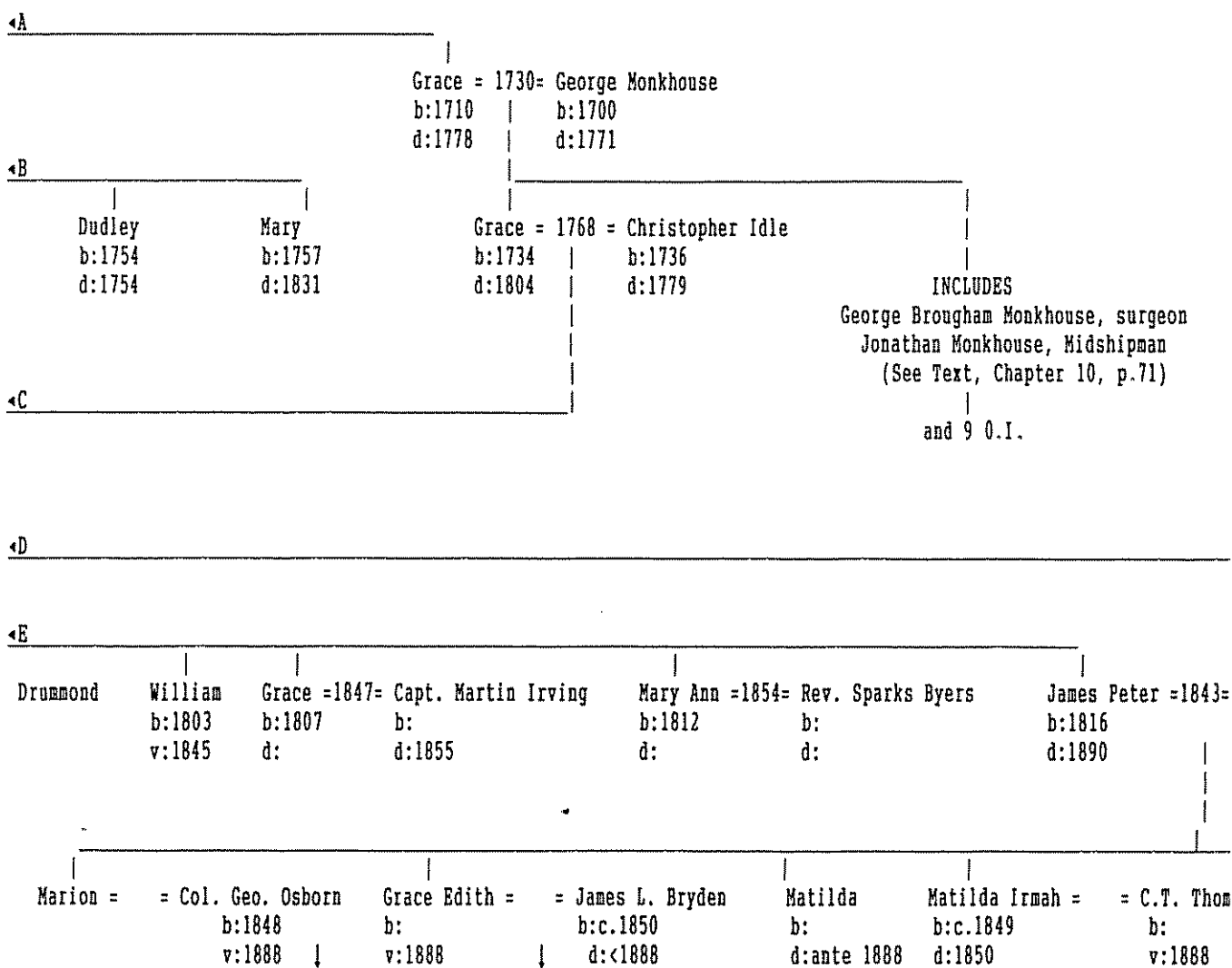

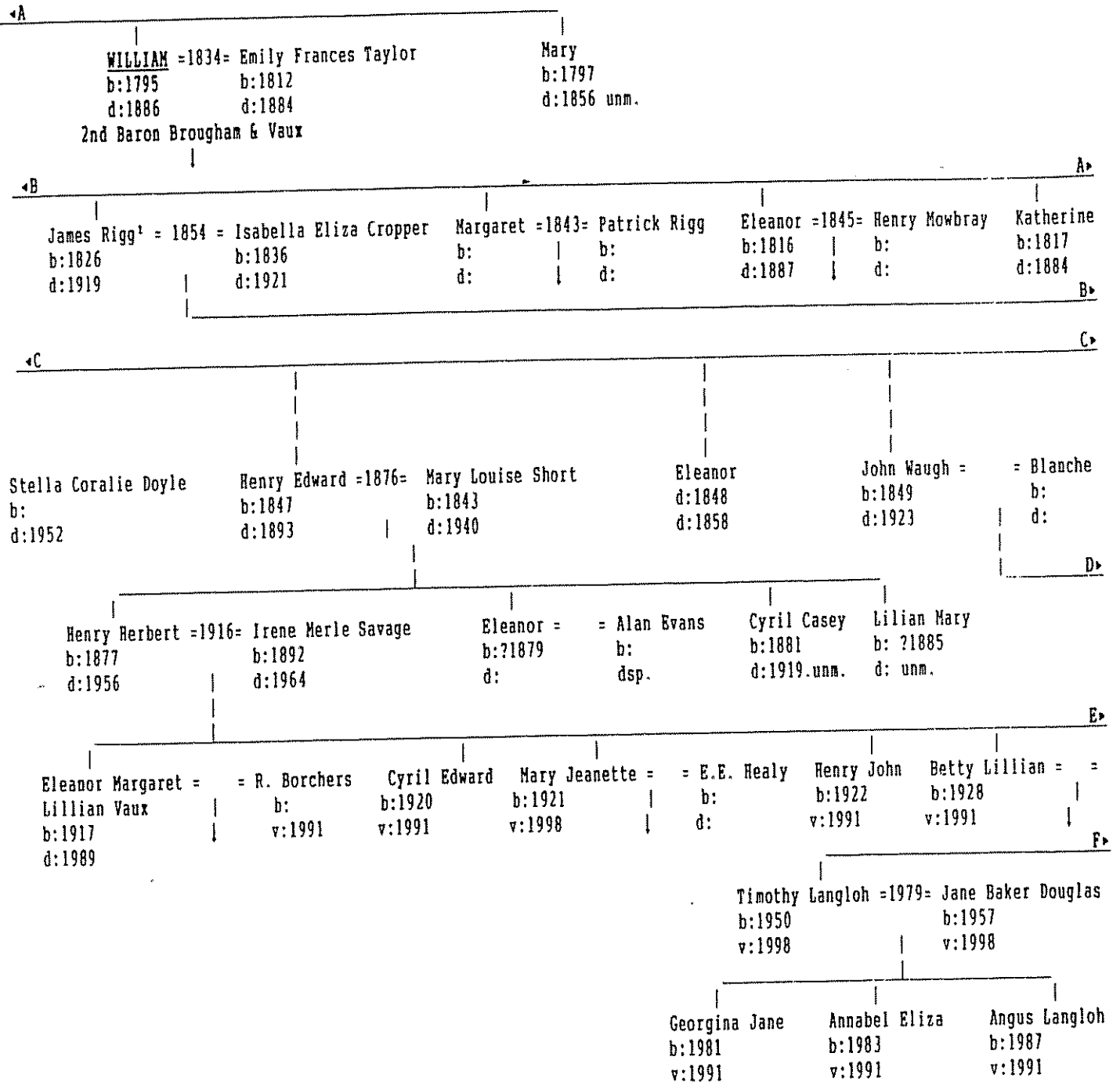

NOTES

1. Lived in Edinburgh from c.1770 until 1790, when he retired to Brougham Hall. It is doubtful if he had ever lived at the Hall prior to ca.1770. Existing documents show him as of Castle Yard, Holborn, Co. Middlesex.
2. Was an Addiscombe Cadet in 1830, but transferred to the Bengal Cavalry 1832. Died at Karnaul, 10 October 1839.
3. Went to Australia (NSW) in 1838 and was subsequently disinherited by his uncle. His early years as a pastoralist were very successful, but a run of bad seasons and rash decisions ended his land-owning dreams. His final years (1876-1905) were spent as a Police Magistrate, and he died at Gunnedah NSW 23 August 1905.
4. Followed his elder brother to Australia in 1839, and in conjunction with Patrick and their Kennedy relatives had early success; but he, too, failed and was bankrupted in 1870. He died at Poolamacca Station, then owned by his son, John Waugh Brougham, 18 September 1890.

NOTES

- James Rigg Brougham was also born in Edinburgh, but completed his training for the Bar in London. He was appointed Registrar in Bankruptcy at the Liverpool court in 1848, and following a subsequent move to London in the 1860s was appointed Senior Registrar in Bankruptcy at the High Court in 1891, a position he held until his retirement in 1917. He died at Beathwaite Green (Levens), Westmorland 5 March 1919.

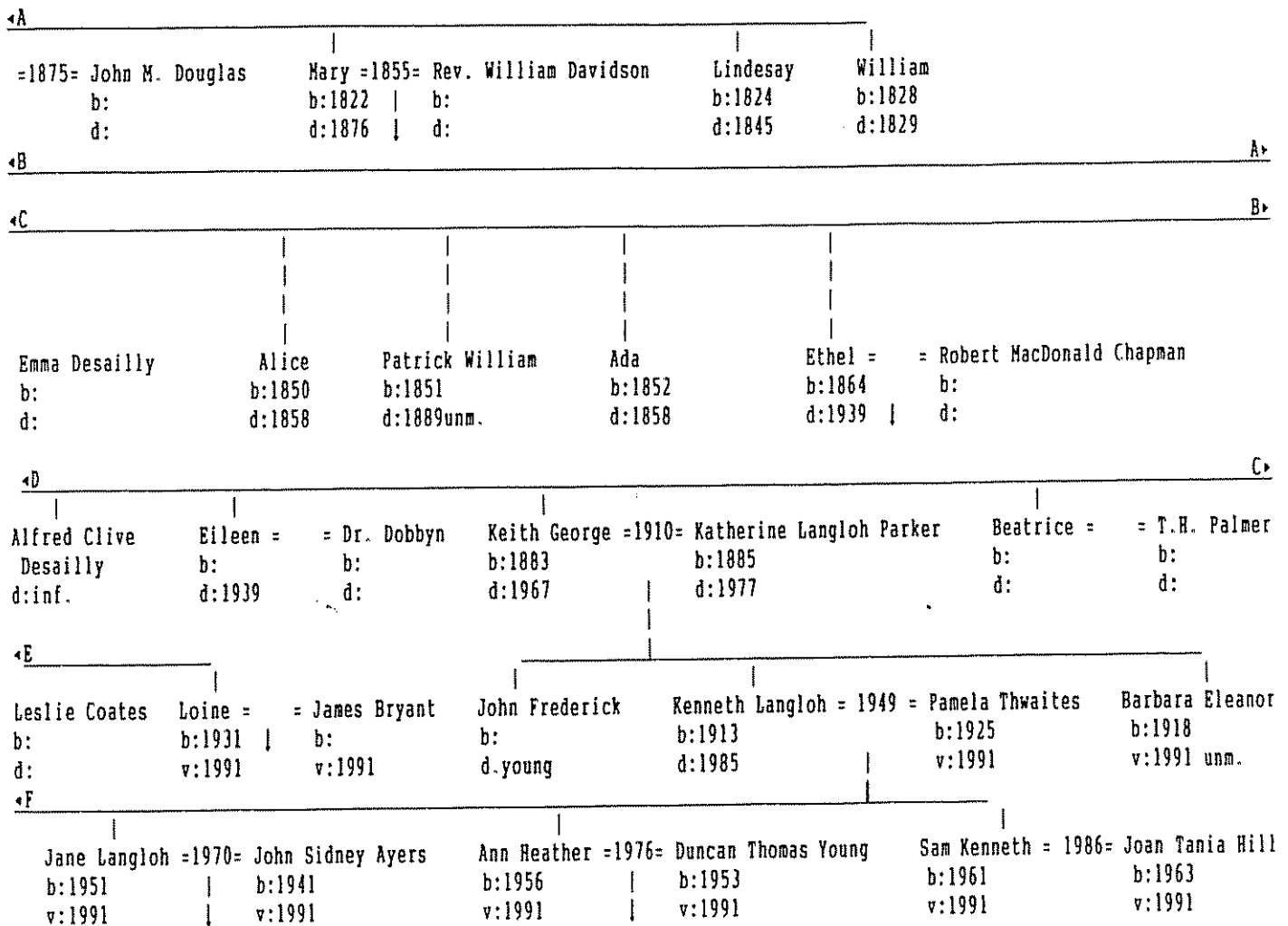

1. Educated at Eton and King's College, Cambs: BA 1771; MA 1775: Fellow 1770-1778. Dean of Ely Cathedral 1771 priest 1773: Rector of Ballyhaise and Bailleborough, Diocese of Waterford, Ireland.
2. Rector of Tallow, Diocese of Lismore: His wife, Catherine, was the daughter of Sir John Macartney of Lish, Bt., by his second wife, Catherine, daughter of the Rt. Hon. Walter Hussey Burgh, Lord Chief Baron of the Court of Exchequer in Ireland.
3. Rector of Monkstown, Co. Cork, and Canon of Christ Church, Dublin. He was a witness at the marriage of his 2nd cousin, James Rigg Brougham to Isabella Eliza Cropper in Liverpool, 6 October 1854.
4. Educated Trinity College, Dublin. Classical Moderator and Gold Medallist 1847. Dean of Lismore from 1873.
5. Was in Adelaide, South Australia, in 1908. Died at Freshwater, Isle of Wight.
6. Educated St. Columba's College, Ireland, and Keble College, Oxford. All-round sportsman and horseman. Housemaster of Wellington College, Berks. His wife was the daughter of Judge Lauer of Krefeld, Germany.
7. Married and died (date unknown) in Queensland, Australia. His only son, Roland, died young.
8. QC 1888, and a Deputy High Court Registrar in Bankruptcy.

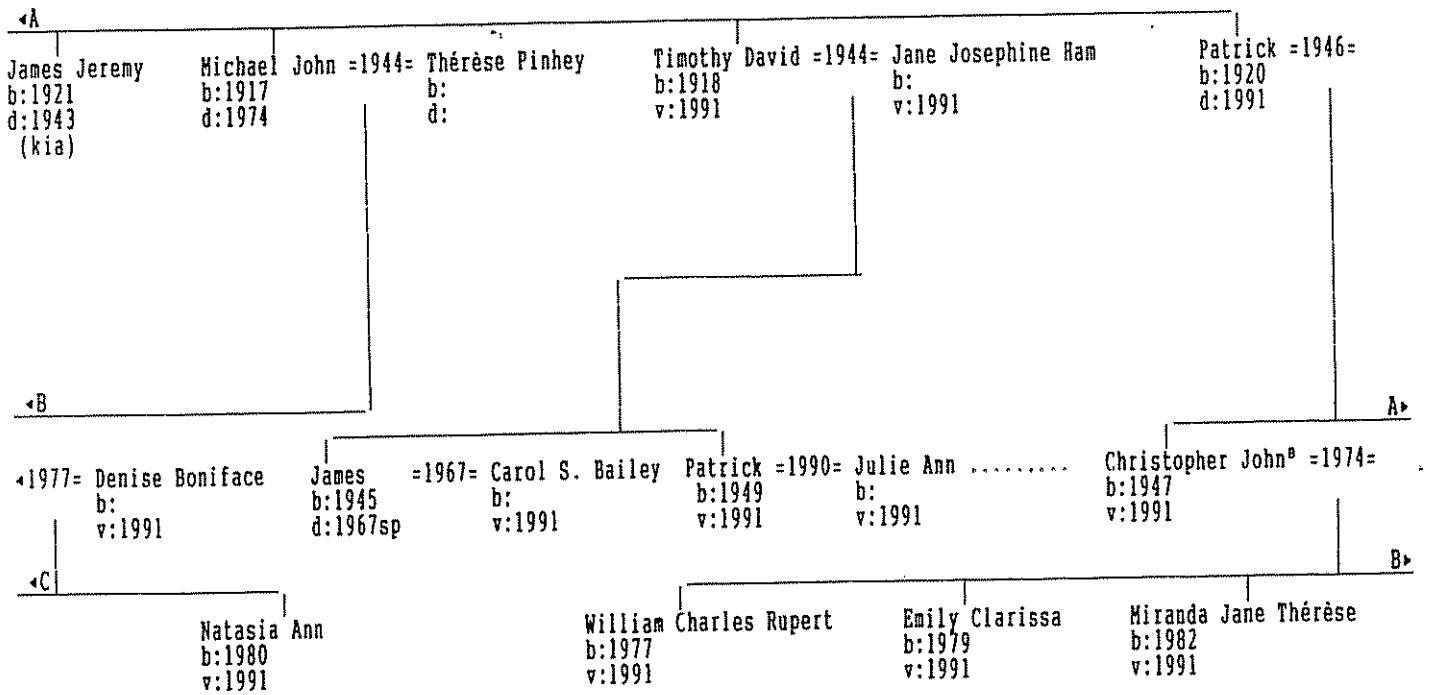

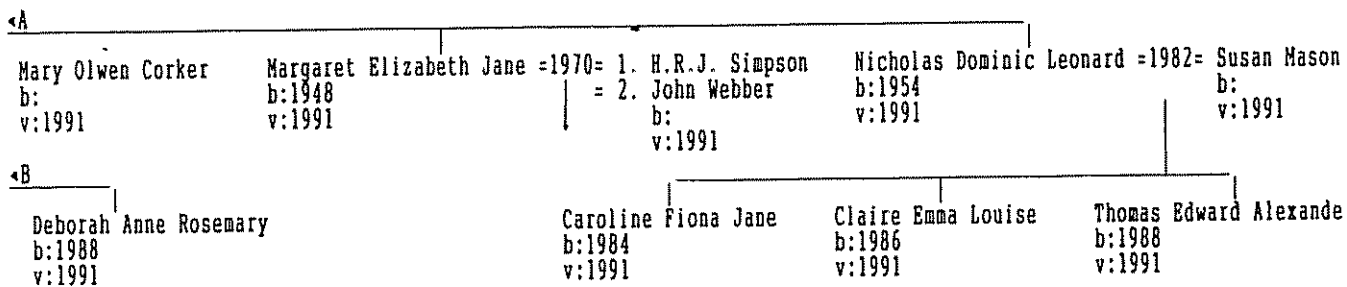

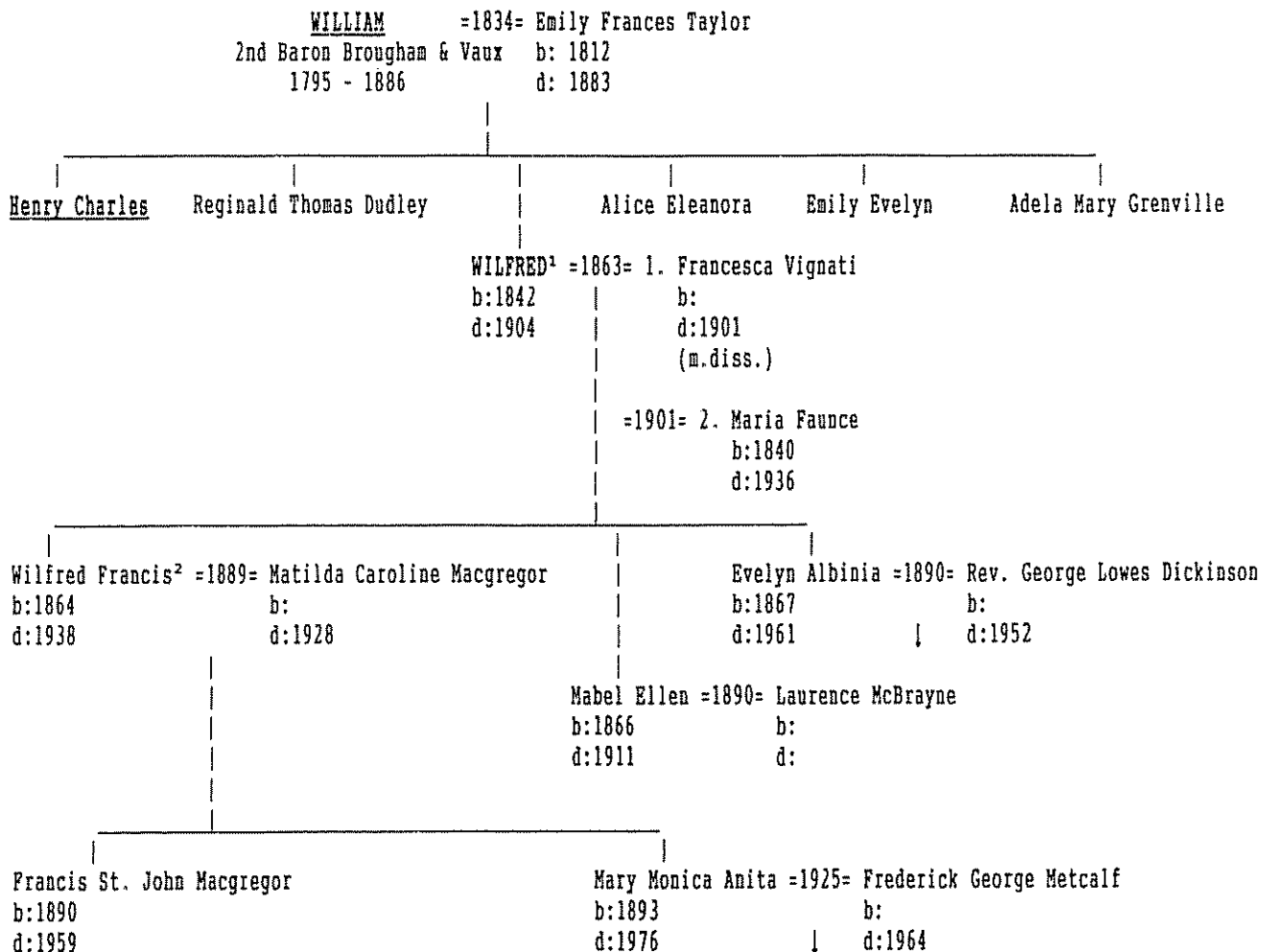

NOTES

1. Hon. Wilfred Brougham was of Grangehill, Guernsey.~ He was commissioned into the 10th (Prince of Wales's Own) Hussars in 1859 (Cornet, 18.02.1859; Lieutenant 10.05.1861), and transferred to 17th Lancers 12 December 1865. He resigned his commission in this regiment in 1865, and his father bought him a commission in the Westmorland Militia which so incensed the senior subalterns that they threatened to resign. Wilfred himself resigned in 1868, and in 1869 Lord Brougham noted in his diary that he had made a new will, 'omitting Wilfred'. Wilfred was later reinstated, with reservations.

2. Educated Charterhouse and Pembroke College, Cambs. (Admon. pens.1 October 1885), BA 1888. Solicitor, (Messrs. Day, Russell & Brougham of Norfolk St., Strand, London). Solicitor of the Supreme Court of British Columbia: Assistant Solicitor to Canadian Pacific Railways

There seems to be little doubt that the Edward Brougham who heads this chart was related to the Broughams of Brougham Hall (though in 1725 they were still of Scales Hall, Skelton, Cumberland).

The marriage of Matthew Brougham the Elder to Ann Nixon is pure conjecture, but it is the only possible solution. We know from correspondence that has survived that his father married twice (and was the only one of Edward Brougham's sons to do so), and that his half-sister Ann married a Nixon - and we have confirmation of that marriage in 1757. Matthew's youngest son, Stephen, trained as a surgeon at Guys and St. Thomas's hospitals, and named his elder and only son to survive to adulthood, Matthew Nixon.

John Brougham of Bush Nook - from his marriage with Eleanor Carrick - had been an Excise Officer, as had at least two of his brothers, and it is also very likely that his father was also, though the records for that period are very scanty. All had been sponsored into the service by John Brougham, Commissioner of the Excise, who bought Brougham Hall from the heirs of James Bird, a former steward to the Lady Anne Clifford.

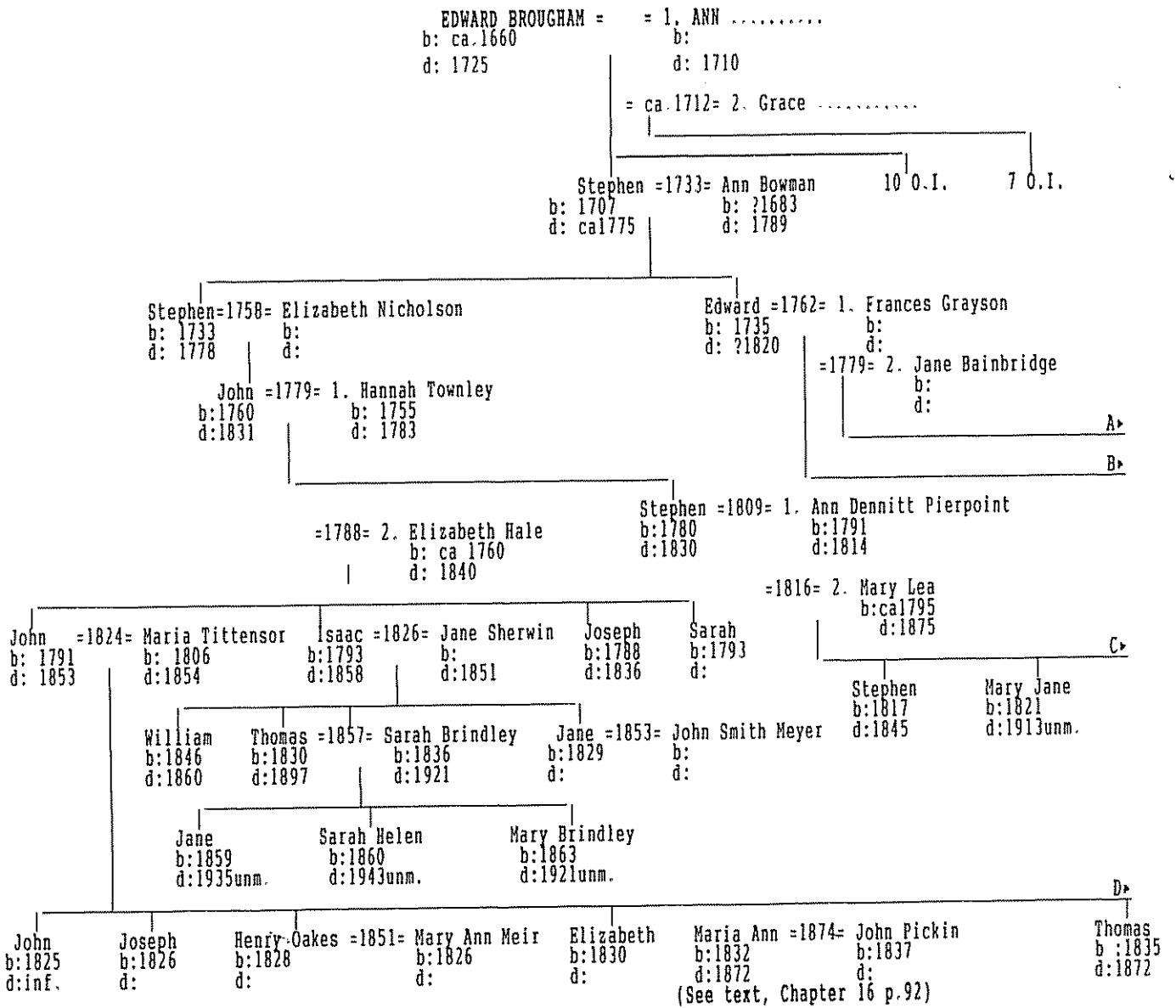

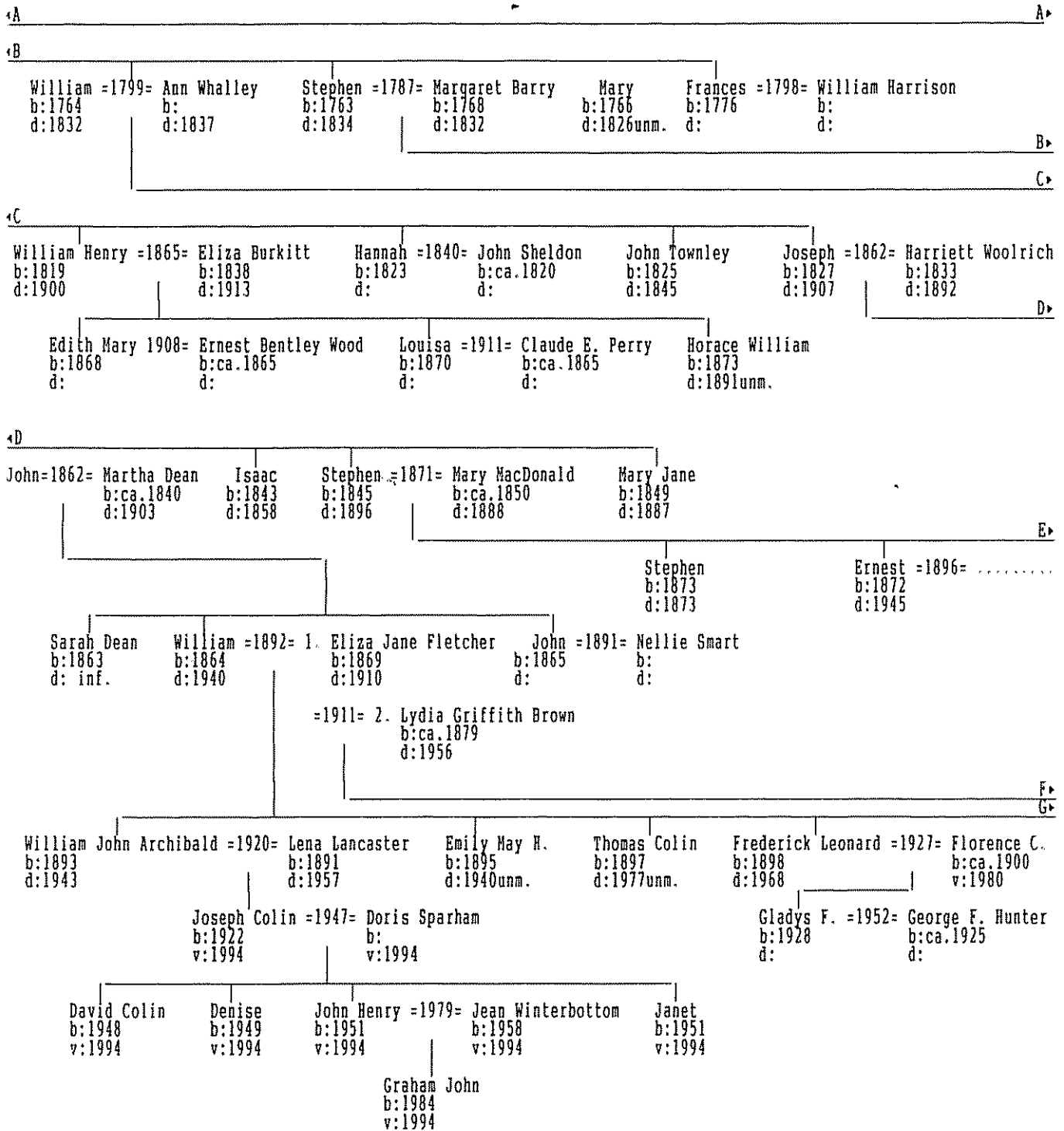

Having made provision for every other accountable member of the family, he then goes on to say that 'the remainder of the paternall estate has not been sufficient to supply the necessitys of our poor relations and to maintain and educate their many children....'

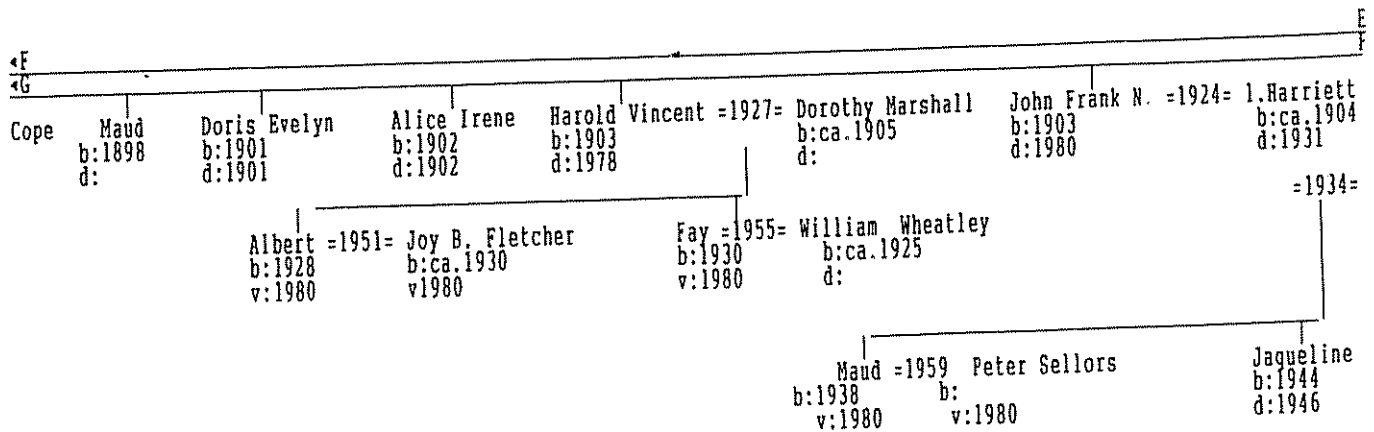
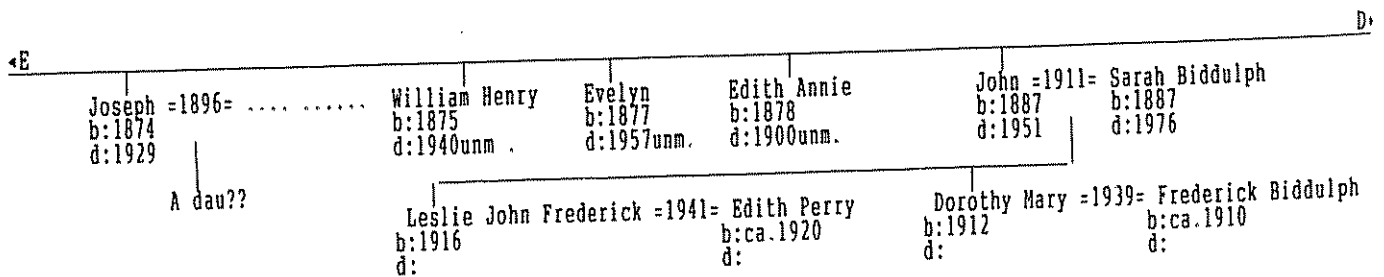
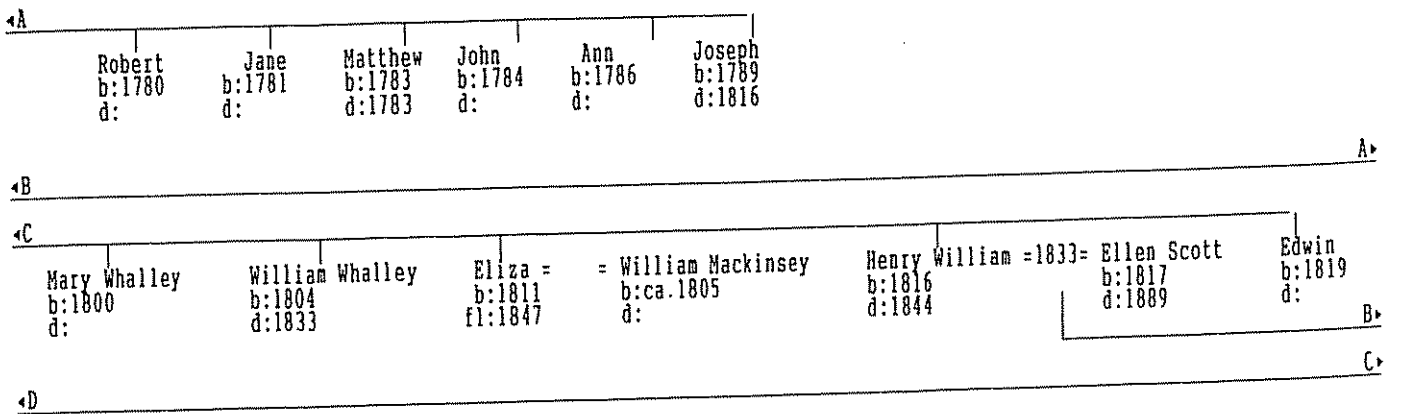
Only Edward of Barns with his 18 children fits this bill - and he had been dead 16 years when the Commissioner died. There also exists a note from Rev. Matthew Nixon Brougham's sister which reads: 'Your father's cousin, Mr. John Nixon, states that the Lord Chancellor's grandfather, and your grandfather (John Brougham of Bush Nook) were second cousins'. If this were so, then both had a common ancestor in Thomas Brougham of Eamont Bridge and Scales, whose eldest son, Henry, founded the family fortunes: he was the father of Commissioner Brougham. But which of Henry's four brothers could have been the father of Edward is not known. Thomas and William are the most likely candidates, but there is no proof.

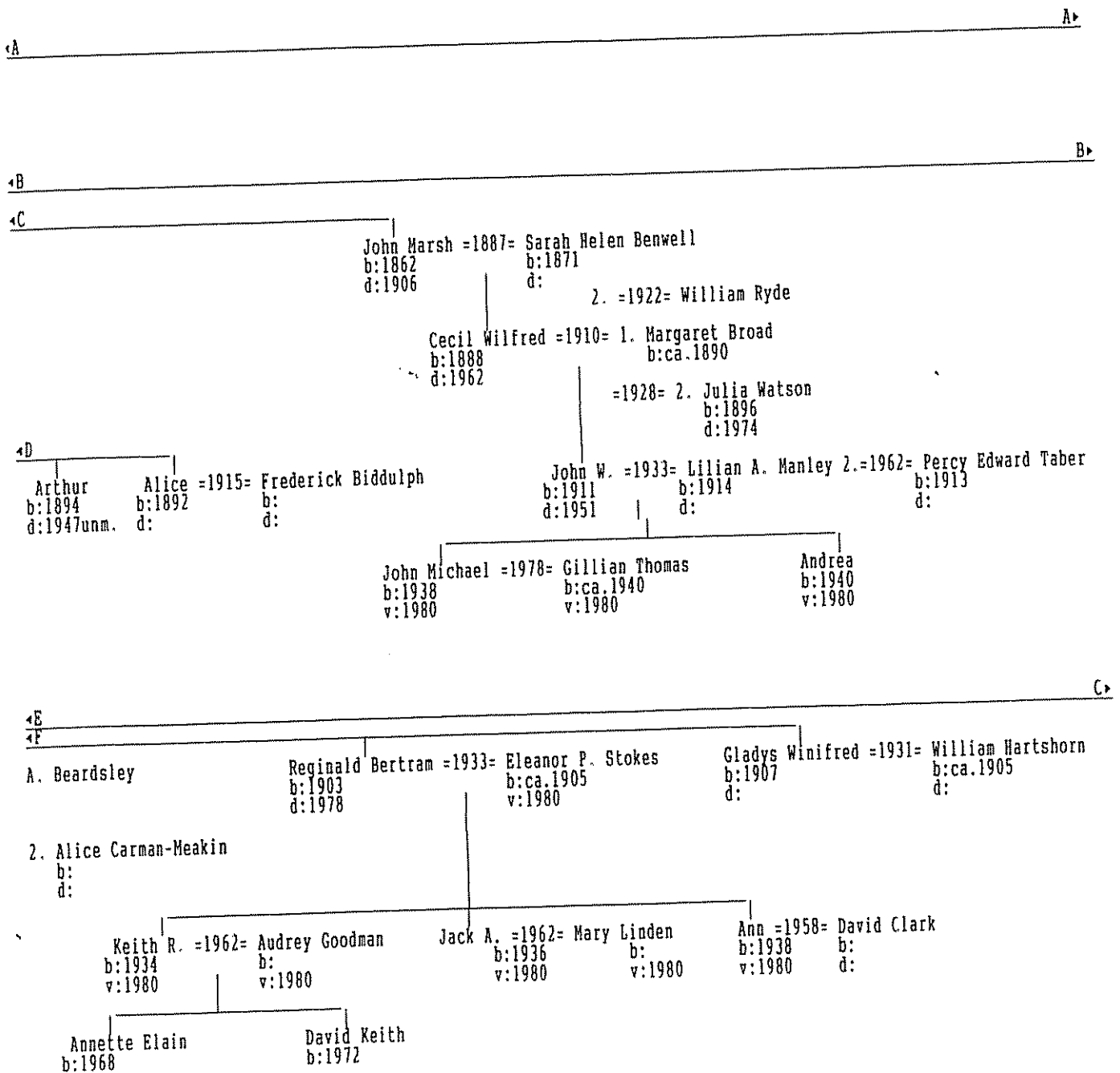

1707 - ca.1775



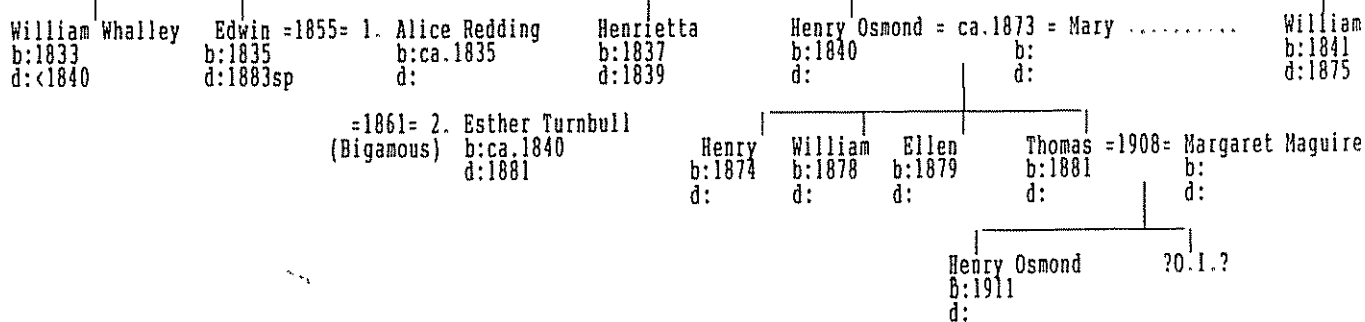




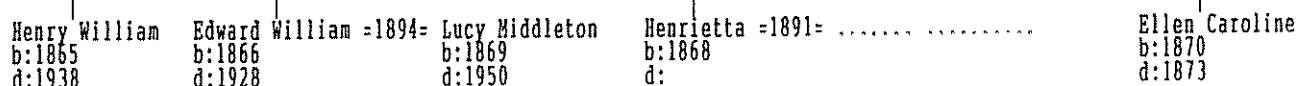

We know from correspondence that has survived that his father married twice (and was the only one of Edward Brougham's sons to do so), and that his half-sister Ann married a Nixon - and we have confirmation of that marriage in 1757. Matthew's youngest son, Stephen, trained as a surgeon at Guys and St. Thomas's hospitals, and named his elder and only son to survive to adulthood, Matthew Nixon.

John Brougham of Bush Nook - from his marriage with Eleanor Carrick - had been an Excise Officer, as had at least two of his brothers, and it is also very likely that his father was also, though the records for that period are very scanty. All had been sponsored into the service by John Brougham, Commissioner of the Excise, who bought Brougham Hall from the heirs of James Bird, a former steward to the Lady Anne Clifford.

 BOMBAY ARMY

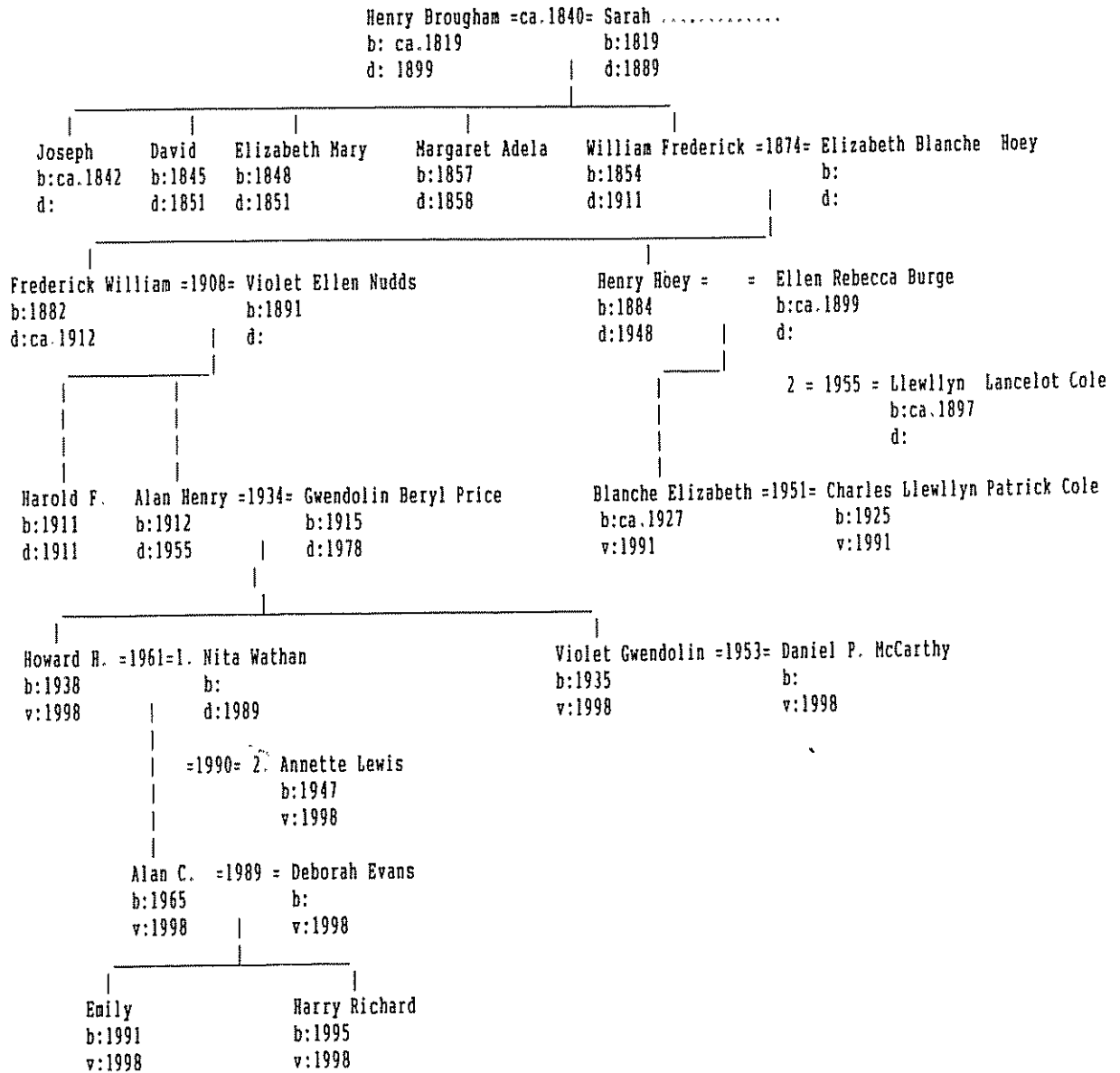

THE DESCENDANTS OF FREDERICK JAMES BROUGHAM

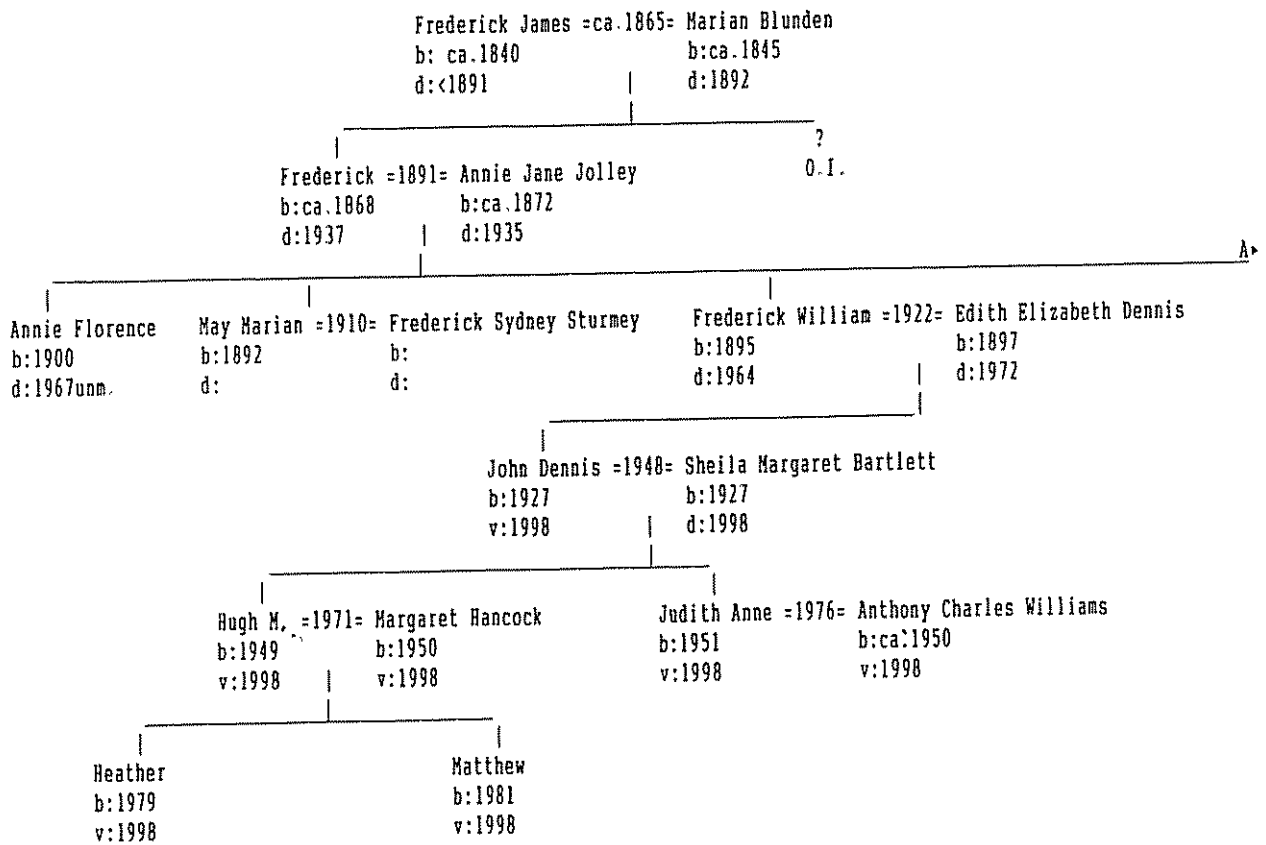
